One of the first of its kind for a major US city, the program leapfrogged from no disposal options for more than 150,000 households to a low-cost, easy-to-use, door-to-door program.
- Innovative. With Vail Resorts/RockResorts, she co-created and led the first luxury-brand volunteer vacation program -"Give & Getaway." This seasonal program coordinated with local conservation non-profits across the international hospitality portfolio, was popular with guests, and copied by other luxury hotel brands.
- Bottom-line Focused. As Director of Environmental Affairs at RockResorts/Vail Resorts Hospitality, she led a program that helped save Vail Resorts \$3 million in energy costs. Water on the Rocks cut disposable plastic bottle use by 550,000 annually.
- Seamless Integration. In all her roles, she successfully led cross-functional teams to develop sustainability vision, strategy, goals and metrics. She takes a systematic approach to address such key impacts as water, waste, energy, and stakeholder engagement.
